# 6.1 BRC Area Manger - Elliott Operations Report October 23

### RECOMMENDATION

That the Local Authority receives and notes the Area Manger – Operations Report for October 2023

### **SUMMARY:**

This report provides the Elliott Local Authority with an opportunity to review council operations that have occurred in the Elliott community since the last LA meeting.

**Fleet Management** – A request has been lodged with the manager of BRC fleet equipment in Tennant Creek for the relocation and use of a grader currently stationed at the council depot.

This machine is urgently needed to complete the fire breaks around Elliott.

BRC services – There have been some rather major changes to staffing and leadership within council in the last week. The acting CEO Russell Anderson, who was originally due to finish his tenure at the end of August, opted to stay on until November when it is expected that the new CEO Mr Ian Bodill would be assuming the role, however due to unforeseen circumstances, Mr. Anderson was unable to continue and his last day with BRC was Friday 29 September 2023. Other staffing changes have occurred and are still in progress and The Operations Director will endeavor to put a more comprehensive list together for the next LA meeting. A request from Adrian Chong has been actioned to communicate with Aus Projects regarding the maintenance of yards in the community as lack of clearing is posing a fire risk.

**Action Items List** – As the role of operations director becomes clearer to me, I have discovered what an excellent progress tool the action tracker is. As time permits, I will study the history of projects in Elliott and make full use of the AT going forward.

**Community visits** – Australian Electoral Commission (AEC) have been in town for the Voice Referendum pre-poll.
