SUMMARY:

As we come out of the COVID-19 response, Council activities have returned to normal operations. All Council facilities and activities have now re-opened though we continue to abide by social distancing recommendations.

You may be aware our former Mayor, Steve Edgington wo the seat of the Barkly, he has resigned from Council to take up his new position as MLA, Member for Barkly. As a member of the CLP he sits on opposition to the Michael Gunner Labour Government. Our new Mayor is Mayor Jeffery McLaughlin, unfortunately Mayor McLaughlin could not be present today, I am sure he will be at the next Youth Council Meeting.

We have numerous priority project on the go at the moment with work continuing with DIPL on the Pukiss Reserve redevelopment, work on TC cemetery, \$450k to install a new playgroup at Lank Mary Ann and 5 construction project in communities from the \$1m drought funding.

The new Tennant Creek Youth Centre tenders have closed and are currently being assessed in preparation for Council to make a decision on the winning tender. This will be the first of the Barkly Regional Deal BBRF projects to commence construction. The other BBRF projects are continuing to be finalised including the new bike path along the main drain.

Council received some extra road funding from the Federal Government, this means we will be able to do two road project in the new financial year, the major project will be to re-sheet Ampilatwatja's roads. We also hope to re-sheet some key roads in Tennant Creek.

There was also money from NTG to build some new infrastructure. Council has considered the options and decided to build a small chapel and toilets at the cemetery. This will be a welcome addition to the cemetery and fits in well with the current beatification that has commenced at the cemetery thanks to the Local Authority allocating funds for landscaping.

In response to the COVID-19 outbreak Council has frozen all rates, fees and charges at current levels for the new financial year. This does keep out income down for the year while costs continue to rise so Council will have to carefully manage the budget in the new year.
